## Staff's Release for Participation

This release shall be binding even if the risks and liabilities that are being released by this document arise out of the negligence or carelessness of one or more of the Released Parties. I *further agree* to defend, indemnify and hold harmless, the Released Parties from, for and against any and all demands, claims, disputes, actions, causes of action, liabilities, losses, damages, penalties, recoveries, judgments or executions, costs and expenses, of every name and nature, **in law in equity**, arising out of my participation in the Camp(s). Furthermore, this release shall allow the Released Parties to use photographs of me at the Camp(s), as well as my name, for publicity and promotional purposes for no further consideration. This Release shall take effect as a sealed instrument and shall be governed by the laws of the States of Massachusetts, Maine, New York, Texas, Tennessee, Illinois, Colorado, North Dakota, Pennsylvania, Missouri, New Jersey, and the Province of Onatario, Canada. This release is intended to be binding on me, my spouse, my parents and/or any other family member or legal representative/guardian.
